WE MADE THE FINALS! ON THE WAY TO BUILDING BACK BETTER

EWDD was part of a coalition led by the [Los Angeles Economic Development Corporation \(LAEDC\)](#) that was recently selected as one of 60 finalists for the [U.S. Economic Development Administration's \(EDA\) \\$1 Billion Build Back Better Regional Challenge Grant](#). The grant is intended to accelerate the nation's economic recovery from COVID-19 by building local economies that will be resilient to future economic shocks.

Phase 1 of the Build Back Better challenge invited coalitions to submit grant applications to fund projects in coordination with industry and community

partners, aligned around a holistic vision to build and scale a strategic industry sector. EWDD was part of the coalition assembled and facilitated by LAEDC, which included stakeholders from government, business, nonprofits, and academia. Together, the team proposed several coordinated projects to advance equitable and sustainable growth in the Goods Movement Ecosystem, leveraging the innate convergence of blue and green economies at LA's ports and beyond to grow new jobs and enterprises for the region, particularly for historically excluded populations, said LAEDC CEO Bill Allen.

As a finalist, the coalition is being awarded \$500,000 to further refine its plans to build projects that position LA as a more environmentally responsible creator of value from the ocean, upon which the region's position in global commerce depends. By advancing to Phase 2, the coalition is competing for up to \$100 million in American Rescue Plan funding.


EDA received 529 applications from regions in all 50 states and five territories. The challenge is the largest economic development initiative from the U.S. Department of Commerce in decades. The deadline for Phase 2 applications is March 15, 2022.

GRANT FUNDS JOB OPPORTUNITIES TO RESTORE LANDSCAPES

The California Employment Development Department (EDD) National Dislocated Workers Grant (NDWG) provided paid work experience for workers to assist with recovery efforts to residents and businesses that were severely impacted by the state's megafires. The NDWG also funded temporary employment opportunities for individuals who lost their jobs during COVID-19.

EWDD's WorkSource Centers and workforce partners helped administer the NDWG, which has provided temporary employment to hundreds of Angelenos.

This project is 100% federally-funded in the amount of \$1.8 million.

He is currently utilizing the skills he has acquired and strives to keep learning as his career continues.
